Gov. Malloy and Delegation Announce Federal Grant to Help Once -Incarcerated Veterans Receive a 'Second Chance,' Gain Employment, and Avoid Homelessness

Bridgeport's The WorkPlace Receives \$130,000 Grant to Assist 'At Risk,' Formerly Incarcerated Veterans with Employment Services

(HARTFORD, CT) -Governor Dannel P. Mallov and members of Connecticut's Congressional delegation today announced that the U.S. Department of Labor's Veterans' Employment and Training Service has awarded The WorkPlace with a \$130,000 grant to provide services that will assist formerly incarcerated veterans considered "at risk" of becoming homeless in finding meaningful employment. The Incarcerated Veterans Transition Program grant focuses on providing job referral and counseling services, and will be used to supplement the Governor's Second Chance Society goals of ensuring that nonviolent offenders are successfully reintegrated into society and become productive members of Connecticut's economy.

The WorkPlace, located in Bridgeport, is one of the state's five Workforce Development Boards and is a partner in the state's goal to end veteran homelessness. Last month, the United States Interagency Council on Homelessness certified that Connecticut had become the <u>first</u> <u>state in the nation</u> to end chronic veteran homelessness.

"We are making Connecticut a Second Chance Society, and that's lowering crime, boosting jobs, and ending the cycle of crime and poverty. For too long, we invested in permanent punishment instead of permanent reform, and we built modern jails instead of modern schools. Each day, we are investing in permanent reformation instead of permanent punishment, as we help people get back on their feet. This grant will no doubt help in these efforts," Governor Malloy said. "We have ended chronic homelessness among veterans, and with this grant. we're helping those who have served America get a job to help give them a second chance and avoid homelessness altogether."

"We must ensure that our veterans re-enter our communities as productive, accountable citizens - and this funding will help us help them achieve those goals," Lt. Governor Nancy Wyman said. "Homelessness and joblessness are terribly damaging cycles, putting these resources in place will protect residents, families, and communities."

The WorkPlace will partner with the state's Department of Correction facilities to identify veterans slated for release from incarceration within six months, or those released within the previous 12 months. Enrolled participants will receive mentoring, job readiness skills and job search assistance from the Connecticut Department of Labor, and will be connected to the Department of Veterans' Affairs. Program participants will also receive individual career plans, including goals related to personal issues, such as counseling, substance abuse treatment, housing, and child custody/support issues that can affect workplace success. The focus will be placed on continuing education, vocational training and employment placement.

"This grant enables us to continue to offer some of the most comprehensive services to veterans in the American workforce system," Joseph Carbone, President and CEO of The WorkPlace, said. "This program will be implemented with the guidance of collaborative partners creating a holistic approach to meeting the needs of veterans. We will increase employment while enhancing their probability of career attainment."

"Ending chronic homelessness is a testament to the sustained. tireless work of advocates who have devoted their lives and careers to the cause. Maintaining this major milestone will require sustained vigilance and relentless commitment," Senator Richard Blumenthal said. "The Work-Place has been on the front lines of that effort, working to address the root causes and risk factors that lead to veteran unemployment and (continued on page 4)

homelessness - including incarceration. I applaud their life-changing work and commend the Department of Labor for their wise investment."

"The men and women who have served our country should never be without a home. But too often, formerly incarcerated Americans, including our veterans, face unreasonable barriers that prevent them from securing gainful employment, limiting their ability to care for themselves and their families," Senator Chris Murphy said. "This important grant from the Department of Labor will help Connecticut's vulnerable veterans secure stable employment, and I look forward to seeing this award reinforce the state's work to end chronic veterans' homelessness."

"We reveal a lot about our society through the way that we treat our veterans," Congressman Jim Himes said. "So many of our young veterans have spent more time than anyone ever should in the line of fire, and have returned home with the physical, emotional and psychological scars to prove it. When they end up incarcerated, or otherwise involved in the criminal justice system, it is a true tragedy. I am hopeful that this grant can get as many vets as possible back on their feet and help them rebuild their lives."

"The process of ending veteran homelessness in Connecticut consists of strong collaboration and a coordinated effort among several key stakeholders across the state," Connecticut Department of Housing Commissioner Evonne M. Klein said. "In addition to identifying and housing homeless veterans as soon as possible, we also need to address their long-term needs. This grant from the federal government ensures that we have the necessary tools to help our veteran's find permanent employment, keeping them in their homes for the long term. Our veterans have sacrificed so much for our state and for our country and it's a privilege to be able to serve them."

"Often the most important step in ending homelessness for our veterans is connecting them to a job," Connecticut Department of Labor Commissioner Sharon M. Palmer said. "Working in partnership with The WorkPlace, our agency's veterans' representatives will be providing employment services that include résumé development, workshops for skills building and interview assistance, as well as help connecting them to employers. We look forward to taking part in a program

that helps our veterans, their families and ultimately puts people to work."

"This program is just another example of our efforts to give offenders a second chance and ultimately reduce recidivism," Connecticut Department of Correction Commissioner Scott Semple said. "By providing veterans, who are returning to the community, the tools with which to find employment we are to a small degree repaying them for their service to our country."

"This is an exciting time for Veterans in Connecticut as we have become the first state in the union to end chronic homelessness through the coordination and determination of Governor Malloy and the various departments," Connecticut Department of Veterans' Affairs Commissioner Sean Connolly said. "Now, we will continue to narrow the gap with these critical next steps of prevention that focuses on our incarcerated Veterans. It is a big win for our Veterans."

Connecticut has been nationally recognized as a leader in the effort to prevent and end homelessness. Last year, Governor Malloy joined a <u>small coalition of states</u> to develop a comprehensive plan to end veteran homelessness by the end of 2015. To date, Connecticut is on track to meet this goal, which was reinforced by <u>the August announcement</u> that the state has ended chronic veteran homelessness.

Fairness Committee seeks input for reforms in Delaware criminal justice system

A series of public hearings began in Wilmington on Thursday, October 22, aimed at fostering equitable treatment of criminal offenders and improving public safety.

The Committee on Fairness in the Criminal Justice System-comprised of a cross-section of the Delaware Bar, community and business leaders, and academia--was assigned by the Access to Justice Commission set forth by the Delaware Supreme Court.

Greg Williams--former president of the Delaware Bar and co-chair on the Fairness Committee--alluded to the overwhelming instances of racial disparity as the driving force for these hearings.

"The numbers suggest that Delaware's population is about 22 percent African American," he disclosed, "yet African Americans make up about 60 percent of the state's prison system."

Bart Dalton--the other cochairman and former Delaware Chief Deputy Attorney General--explained the role of the Fairness Committee.

"The purpose is to look at this

disparity and to take testimony, to gather facts, to try to figure out the reasons," Dalton revealed, "whereby we can, if possible, decrease the disparity that we see in the numbers without compromising and, in fact, enhancing public safety."

The hearings--divided in two parts--will consist of informational hearings on October 22 and November 13, 2015, and then a series of public forums throughout the state in December to allow for public comment. The eventual goal is for the voting committee to present recommendations to the Delaware Supreme Court that will provide improvements to how the criminal justice system operates.

The informational hearings-soliciting input from the University of Pennsylvania Law School's Quattrone Center for the Fair Administration of Justice, Bryan Stevenson's Equal Justice Initiative, and the University of Delaware-will discuss policies such as policing strategies that have worked elsewhere, risk-based bail, and alternatives to incarceration.

As Dalton pitched, "we should not put people in jail--before they are convicted--if we don't think that they pose a public danger, but they're only in jail because they don't have enough money to post bail."

With such possible solutions as community-based sentences, Dalton suggested that everyone will benefit.

"When we put someone in jail, pending bail, the public's

paying for that person to be in jail. Do we need to do that? Well we do if it impacts public safety. But we don't need to do that if there's a few thousand dollars bail--because that's what we've always done --and therefor that's what we're going to do, and the person is poor. There's no real upside to some of this."

The hearings are:

- October 22, 2015 at the Doubletree Downtown Wilmington, 7th and King Streets, 1 p.m. to 5:30 p.m.
- November 13, 2015 at the Chase Center on the Riverfront, 815 Justison Street, 9:30 a.m. to 5 p.m.

Bail, pre-tial detention, charging and plea bargaining decisions and sentences, and policing strategies implemented in other jurisdictions.

DYRS Youth Visit White House for Justice and Opportunity

Young People Explore the Power of Art in Juvenile Justice Rehabilitation Seven youth from the Department of Youth Rehabilitation Services (DYRS) visited the White House today for "Justice and Opportunity: The Power of the Arts," an event initiated in honor of National Youth Justice Awareness Month.

"This opportunity opened our kids' minds to using the power of art to better understand others and themselves, and the prospect that there is so much out there for them if they commit to the right path," said Garine Dalce, Deputy Director of Youth and Family Services at DYRS, who attended the event. "DYRS firmly believes in the healing power of the arts and implements programming reflective of this for our young people."

The program focused on the importance of the arts in building narratives, empowering communities and furthering youth justice. Youth participated in panels and group discussions where they talked about their experiences and learned about the history of juvenile justice. Afternoon sessions consisted of workshops for them to capture their reflections from the morning sessions though expressive art forms such as poetry slam and graffiti art. Each young person also received a signed proclamation of National Youth Justice Awareness Month from President Obama.

President Obama proclaimed National Youth Justice Awareness Month a time to "recommit to ensuring our justice system acts not as a means for perpetuating a cycle of hopelessness, but as a framework for uplifting our young people with a sense of purpose so they can contribute to America's success."

The advocacy group Campaign for Youth Justice launched National Youth Justice Awareness Month (YJAM) in 2009 to provide people across the country an opportunity to develop youth justice actionoriented events in their communities during the month of October.

"We are thrilled that President Obama declared October Youth Justice Awareness Month. By raising awareness of the thousands of youth in the justice system - most of whom are young men and women of color - and by pointing out that kids are different from adults, President Obama affirmed his commitment to care for some of our most vulnerable children as part of the "My Brother's Keeper" initiative," said Marcy Mistrett, CEO of Campaign for Youth Justice.

DYRS youth and people across the country will continue to participate in National Youth Justice Awareness Month events throughout the month of October.



Camden Vicinage to Hold Drug Court Graduation

The Camden Vicinage will celebrate the anticipated graduation of 16 clients from its drug court program on Tuesday, Oct. 20 at 2 p.m. in Courtroom 63 of the Hall of Justice, 101 S. Fifth St., Camden.

Assignment Judge Deborah Silverman-Katz will address the graduates, family, friends and supporters. Superior Court Presiding Judge Edward J. McBride Jr., who leads the drug court team, will preside over the ceremony. The keynote speaker will be Ben Carter, a life transformation coach.

The drug court program is a highly specialized team process within the New Jersey Superior Court that addresses nonviolent drug -related cases. Drug courts are unique, because they build a close collaborative relationship between the criminal justice system and drug treatment professionals. The program has a proven track record of success in changing the lives of those who suffer from the disease of addiction.

As of September 2015, 346 participants have graduated from the Camden Vicinage Drug Court Program.

New York State recognizes two senior probation officers for service, dedication and professionalism

New York State recently recognized two veteran probation officers for their work supervising sex offenders and their collaboration with other law enforcement agencies in the counties in which they work.

Suffolk County Senior Probation Officer Stephen Larsen and Wyoming County Senior Probation Officer John Lonsberry were honored by the state Division of Criminal Justice Services (DCJS) Office of Probation and Correctional Alternatives during the state Probation Officers' Association annual conference in Syracuse last month.

DCJS Deputy Commissioner and Probation Director Robert M. Maccarone presented Larsen and Lonsberry with the 2015 Director's Award for Outstanding Service by a Probation Officer. The award recognizes exceptional service, dedication and professionalism demonstrated by a probation officer which has significantly contributed to the field of community corrections and strengthened its role within the criminal justice and/or juvenile justice system.

"Through hard work and collaboration with other law enforcement agencies, these honorees have demonstrated how probation officers can make a significant difference to community safety," Director Maccarone said. "Their creativity and commitment to community supervision helps to illuminate probation's critical role in keeping New Yorkers safe."

Larsen was credited for his work in supervising sex offenders, his role as a forensic computer examiner and trainer and his collaboration with other law enforcement agencies. He developed a forensics lab where he conducts searches on electronic devices seized by probation officers and works closely with police to cultivate evidence. He also helped develop a policy and created a training class for probation officers on the use of social media.

Lonsberry has worked with the Wyoming County Probation Department's intensive supervision program for 25 years. For the past decade, he has supervised sex offenders and also collaborates with police agencies assigned to the county's Drug Task Force. His work with sex offenders on probation involves ensuring they receive treatment, as well as appropriate supervision and monitoring within the community.

Probation officers work in each of New York State's 62 counties, supervising more than 108,000 adults and 6,000 juveniles annually. In addition to their supervisory and other responsibilities, probation officers confirm the addresses of nearly 5,000 sex offenders under supervision every quarter, and monitor 26,000 convicted drunk drivers, including those who are required to install ignition interlock devices in their vehicles under Leandra's Law.

The New York State Division of Criminal Justice Services (www.criminaljustice.ny.gov) is a multi-function criminal justice support agency with a variety of responsibilities, including funding and oversight of probation and community correction programs; law enforcement training; collection and analysis of statewide crime data; maintenance of criminal history information and fingerprint files; administrative oversight of the states DNA databank, in partnership with the New York State Police; administration of federal and state criminal justice funds; support of criminal justice-related agencies across the state: and administration of the state's Sex Offender Registry.

Michael L. Green Chairman

Mr. Green received a Bachelor of Arts degree in Sociology from Morgan State University, Baltimore, Maryland and a Master of Science degree in Social Administration from Temple University, Philadelphia.

Mr. Green has over 30 years of experience in community corrections, probation/parole, and court administration, including the establishment of Juvenile and Adult Drug Courts.

He began his career in Philadelphia as a probation officer and moved through the ranks to be appointed First Deputy Chief Probation Officer in Philadelphia County. He coordinated internal operations for the entire adult probation division and met periodically with criminal justice, regulatory and other public agencies. He was central in the formation and management of the Intensive Supervision Program, a county probation/parole prison alternative. He also had management responsibility for the Mental Health, Sex Offender, and Intensive Drug Supervision Units.

In 1991, Mr. Green was appointed to serve as the Chief Probation Officer for Mercer County, Trenton, New Jersey. In this position, he formulated the annual operation plan and budget of over two million dollars, developed policies and directives and enforced statutes and court orders for Adult, Juvenile Probation and Child Support Enforcement. He successfully implemented an automated caseload management system, Megan's Law sex offender and domestic violence supervision programs, and Adult and Juvenile Drug Court programs which, along with other pilots, were adopted statewide. He served as president of the New Jersey Chief Probation Officers Association before being appointed to the Pennsylvania Board of Probation and Parole.

In 2009, he was instrumental in establishing the Berks County Reentry Program with the local judiciary. The Board's court-based Reentry Program, based on the national drug court model, is designed to provide intensive supervision and services to newly released offenders with drug and alcohol issues. In 2014, he established the Philadelphia Reentry Program along with Judge Sheila Woods-Skipper.

On October 5, 2015, he was appointed Chairman by Gov. Tom Wolf. Mr. Green was confirmed by the Senate on October 28, 2003 and re-confirmed on December 16, 2009. He served as acting Parole Board Chairman from September 2004 to July 2005.
