





Carl Robinson Award

Cass Award, the highest professional honor bestowed by the American Correctional Association.

This award is presented to an individual who has demonstrated exceptional efforts to promote professionalism in probation, parole, juvenile justice and/or corrections. It honors the legacy of commitment of the founding members of MASCA, who organized a regional professional organization in 1938.

This year's recipient of the MASCA Founder's Award is: Henry Alexander

Sal Russoniello Service Award

This award is presented to an individual who has demonstrated extraordinary devotion to advancing the educational mission of the Middle Atlantic States Correctional Association. It is named for Sal Russoniello, a parole professional from the State of new Jersey who was the first person to serve two terms as MASCA president.

Harold Miller Community Service Award

Carl Robinson Award

Secretary Carolyn J. Scruggs Maryland Department of Public Safety and Correctional Services

Secretary Carolyn J. Scruggs has always been instrumental in being a true innovative leader in the field of corrections. Citing her vast experience in multiple divisions of DPSCS, Governor Wes Moore named Ms. Scruggs Secretary of the Maryland Department of Public Safety and Correctional Services, on January 13, 2023.

In becoming the new Secretary, Ms. Scruggs made history: she's the first African-American female ever to be named DPSCS Secretary.

Ms. Scruggs is a 27-year veteran of DPSCS who has played critical roles in pretrial corrections and the DOC, including oversight of CJIS and programs, treatment, and services.

She played vital roles in developing both the statewide fingerprint and case management systems, as well as the award-winning Crisis De-Escalation Training.

Starting as a correctional officer at Central Booking in 1995, Ms. Scruggs eventually became the facility's warden, along the way working on the development of critical public safety components including OCMS and MAFIS.

In 2019, she assumed oversight of the department's COVID19 Response Operations, guiding the Department's efforts during a once-in-a-lifetime pandemic.

A graduate from Baltimore's Western High School, she also holds a bachelor's degree in political science from Towson State University and a master's degree in criminal justice administration from Coppin State University.

Most recently, Ms. Scruggs was Assistant Secretary for Programs, Treatment, and Reentry, before being named Acting Secretary by outgoing Governor Larry Hogan.

DPSCS salutes the many accomplishments of Ms. Scruggs and congratulates her on this historic appointment.





MASCA Founder's Award

Henry Alexander Maryland Division of Parole and Probation (Ret.)

Henry Alexander is the recipient of the Founders Award. Henry is retired after a 40-year career with the Maryland Division of Parole and Probation and is a long-standing MASCA Board member. He became MASCA Board President in 2007 and is the only person to hold the office of MASCA President for three (3) terms. He was named the MASCA President Emeritus in 2013. He has also served as a MASCA Conference Program Committee Chair, MASCA Historian, and is currently the MASCA Scholarship Committee Chair.

Henry was previously awarded the Sal Russoniello Award at the 69th MASCA conference. Henry has been very instrumental in putting together this year's MASCA conference and he continues to ensure that an emphasis is placed on education in the field of corrections.

The Maryland Police and Correctional Training Commissions

The Maryland Police and Correctional Training Commissions ensures accountability and professionalism in the field of corrections by providing evidence-based certified training and certification for police and correctional professionals, to ensure that all individuals are treated respectfully and fairly and within the legal and policy guidelines when performing job duties and as private citizens.

The Police Training and Standards Commission is the body established by the Maryland Legislature to govern police certification and training in the State. The original Police Training Commission was established in April 1966. The Commission was abolished September 30, 2016 by the State legislature and the newly created Police Training and Standards Commission was established October 1, 2016. The Correctional Training Commission was established in 1971 by the Maryland Legislature. It is the membership of these Commissions that establishes the training objectives for entrance-level correctional and police officers, annual in-service, First Line Supervisors, and First Line Administrators.

Each Commission is comprised of representatives from Maryland public safety organizations, individuals from the community and university representatives. The agency that supports the Commissions and operates the Public Safety Educational Training Center (PSETC), is the Maryland Police and Correctional Training Commissions (PCTC) located in Sykesville (Carroll County), Maryland. The staff that support the Commissions are located at PSETC. Information about PCTC and PSETC may be found at https://mdle.net/

Professional training and support services are offered at the PSETC for state, county, and municipal agencies. In addition to the staff that support the Commissions, the PSETC also provides training and administrative space for resident partners including the Maryland State Police, the Department of Natural Resources, and the Department of Juvenile Services. Harold Miller Community Service Award

The Maryland Division of Parole and Probation

The Maryland Division of Parole and Probation is the recipient of this award.

This state agency has 36 field offices, and each office contributes to the well-being of the clients, families and the communities. The Maryland Division of Parole and Probation (DPP) contributes through promoting functions such as clothing closets, shoe drives, giving away bicycles, prom dress give aways, mittens and hats, sponsoring families at Thanksgiving and Christmas, Monthly Mobile Food Bank, school drives and drives for DV shelters to name a few. Not only does DPP conduct charity drives, DPP always participates in community engagement, including Job Fairs, Juneteenth, National Night Out, Faith and Blue, Walk for Life and presenting at schools to share with students what the Division is all about.

In addition many team members of the Division are foster parents, coaches, pastors, Sunday school teachers, music teachers, foster fury parents, as well as volunteer firefighters and paramedics.


Dennis R. Martin was a visionary.

Visit the facility that trains correctional officers and law enforcement officers in the state of Maryland.

Correctional professionals in Maryland are governed by the Correctional Training Act, Correctional Services Article. Police professionals in Maryland are governed by the Police Training Act, Public Safety Article. Information about each of these statutes is available at:

Correctional Training Act, Correctional Services Article Police Training Act, Public Safety Article

The Police Training and Standards Commission is the body established by the Maryland Legislature to govern police certification and training in the State. The original Police Training Commission was established in April 1966. The Commission was abolished September 30, 2016 by the State legislature and the newly created Police Training and Standards Commission was established October 1, 2016. The Correctional Training Commission was established in 1971 by the Maryland Legislature. It is the membership of these Commissions that establishes the training objectives for entrance-level correctional and police officers, annual in-service, First Line Supervisors, and First Line Administrators.

The training facility has an administrative building - classroom, gym with an inground pool, shooting range and driving range.

Youth Detention Center

The Youth Detention Center is a state-of-the-art detention facility that holds up to sixty juveniles, who are charged as adults. Within the building is a cafeteria, areas for dental care and rooms for medical treatment and suicide observation -- all monitored by nurses

The facility provides all the programs required to adequately support the staff and youth, which includes a fully functional school - the Eager Street Academy, a 35,000-square-foot education facility, serving high school aged detained individuals. By providing a school within the facility individuals have the ability to earn a high school diploma from their home school

The facility includes family and attorney visitation areas, security screening, central control, intake and release, physical and behavioral health areas, offices, and dining. The center features five housing units designed for 12-14 juveniles in single rooms within a direct supervision setting that are organized around a central staircase that quickly and conveniently connects the different areas.

September 13, 2023 – 1:00 PM to 3:00 PM Vehicles for Change

Vehicles for a Change Partners with the Maryland Department of Public Safety and Correctional Services, by providing auto mechanics training and jobs for incarcerated individuals - Cars are donated to Vehicles for a Change - which are then inspected and repaired as needed. Once the car passes an inspection it is sold to individuals who normally cannot afford a car.

Why Vehicles for a Change? Because this non-profit organization makes a positive difference in the lives of justice involved individuals and lower income individuals. Workshop Title: Violence Prevention

Workshop Location: University 2,3,4

Workshop Description: This workshop will review, discuss, and share ideas on what has been done in both juvenile and adult probation in the past, what is being done now, and what we need to focus on in the future to reduce/prevent violence. We will identify the causes of violence to include risk. Decrease/prevent incidents of violence (Is that realistic?). Identify/expand on the support services within the Criminal Justice System, and the communities: Who are our partners? What really works?

Presenter: Robin Player, Field Supervisor 1

Agency: Maryland Division of Parole and Probation

Bio: Robin Player's career began with Parole and Probation on June 9, 1985 in a small office located in Caroline County, Maryland. Approximately nine months later Robin transferred to Baltimore City where she has worked ever since. Robin received her Bachelor of Science Degree from the great University of Baltimore and ultimately received her Master of Science Degree from the same University. From her time as an Agent to a Field Supervisor 1, her motto has remained the same, "If I can Help Somebody.... My Living Will Not Be In vain". Robin continues to strive to make a positive difference in the lives of others.

Workshop Description: Do you want to achieve your career goals and ensure your potential is not overlooked, then It's time to MasterURpiece. Bio: <u>Dr. Yolanda Bethea</u> is an accomplished senior leader with a successful track record of directing the work of organizational unit programs, operations, and administration for public safety entities. She serves as the senior staff and principal management support and advisor to the Associate Director of the Office of Community Supervision and Intervention Services (OCSIS), responsible for supervising approximately 14,000 offenders sentenced to probation or released to parole or supervised release. Dr. Bethea directs the Operational Support Division's work and oversees the work of branch leaders. She serves as the resident subject matter expert for operational matters for OCSIS and ensure execution of goals through project management, policy development, training, programmatic implementation, data analysis, and performance

management of agency strategic performance measures. Dr. Bethea is also responsible for strategic planning and communications for OCSIS, serving as the liaison with internal and external stakeholders on behalf of the agency on significant initiatives. She provides direct oversight of seven correctional program areas, managing the operational budget, including supportive contracts and procurement processes. Dr. Bethea serves as the emergency preparedness and Continuity of Operation Program (COOP) safety manager for OCSIS and develop and conduct emergency preparedness training sessions for senior leadership on agency safety initiatives.

Workshop Title: Communicating from Afar - Building Family Connections

Workshop Location: Stadium 3

Workshop Description: This workshop will begin with questions relating to the issues children with an incarcerated loved one face. A brief interactive presentation on ACEs (Adverse Childhood Experiences) will be offered. Following discussion, the presenters will briefly share our organization's history and present practices, including how we interact with caregivers, children and the person in jail. The workshop will offer in-depth sharing of strategies used at our local detention center/drug rehabilitation site. These will include 'Sharing Fairs' held at the jail during visitations, 'Parenting From Afar', a home grown course taught to both men and women, the 'Bear Project' for parents in jail; the 'Book Nook Take A Book' resource, the Getting Ready For Parole classes, and more. Testimonials and data on the success of programs will be shared, as will books purchased specifically that participants choose and we mail to their children. Time will be given for participants to explore multiple resources and create their own plan for next steps. Workshop leaders will share the benefits of such programs for the person in jail, their children and the staff. Time will be allotted for questions and answers. All participants will receive a list of books used in the program and a handout with specifics about the 'Parenting From Afar' program.

Presenter: Shari Ostrow Scher, Executive Director

Agency: Children of Incarcerated Parents Partnership

Bio: Shari Ostrow Scher is the founder of Children of Incarcerated Parents Partnership (COIPP). Twenty years ago, Ms. Scher's dream of mitigating the impact on a child whose parent was incarcerated came to fruition. Her own father had been sent to prison when she was a teenager. She would take the train to visit him at Sing Sing prison, and vividly remembers watching younger children get into trouble because there was nothing for them to do while waiting. She knew that children suffered trauma and negative effects when a parent went to jail, often leaving with no warning or explanation. As a result, she and a small group of volunteers in Frederick began to create Care Bags that contained a snuggly teddy bear, books on emotions, stationery and stamps for children to write to their loved one, art supplies, a picture frame, a disposable camera and a gift card for processing the pictures, and more. From this humble but heartfelt beginning, Shari branded the unique organization to fulfill her long-ago dream that is now known as Children of Incarcerated Parents Partnership (COIPP). We later learned that no one else in the U.S. was doing exactly this combination of work for this population with an all volunteer group. COIPP's ongoing successes include creating a child-friendly book nook at the detention center, developing curricula for parenting classes, awarding scholarships to colleges, and conducting workshops at national & international conferences.

Workshop Title: More Than Half: Brain Injury in Justice Involved Populations


Workshop Location: Stadium 5

Workshop Description: This workshop will provide an overview of brain injury including its definition, impact on cognition and behavior, and intersection with justice-involved populations. We will discuss how brain injury can affect both risk and responsivity to treatment. Suggestions will be provided as to how to best work with individuals with brain injury and what resources exist for both information and resources for care. At the end of this workshop, participants will be able to: Identify at least three problems with behavior and cognition that often follow brain injury; Discuss their possible impact on risk and responsivity to treatment; Discuss the prevalence of brain injury among justice-involved populations; Identify at least three resources for additional information or services.

Presenter: MJ Schmidt, Training and Outreach Coordinator

Agency: Brain Injury Association of Pennsylvania

Bio: <u>MJ Schmidt</u> is the Training and Outreach Coordinator for the Brain Injury Association of Pennsylvania. She has been working in brain injury rehabilitation for more than 30 years. She is a Certified Brain Injury Specialist Trainer and divides her time between training, research, and recruitment. She is a graduate of the University of Richmond with a Bachelor's degree in Psychology and Women Studies and of Southern Illinois University, with a Master's degree in Rehabilitation Administration and Services. MJ's research interests include brain injury in justice-involved populations, brain injury in older adults, and the early career development of brain injury professionals.

Workshop Title: US Courts Reentry - Panel

Workshop Location: University 2,3,4

Workshop Description: In a general context, panelists can share the following: Operations of federal reentry court programs and information about federal-level reentry initiatives; Research supporting reentry court programming efficiency and reentry initiatives; Hurdles encountered in setting up a reentry court program with various stakeholders (USAO, court, federal defenders, probation, CJA, and service providers); Lessons learned; Programmatic successes; Any insight that may be helpful for state courts when setting up a similar program.

Panelists: Nomi Berenson, Gladian Rivera, Tholyn Twyman, Kimberlynn Reeves, Ed.D., Mia Lamb

Bio: <u>Nomi Berenson</u> - Nomi Berenson serves as an Assistant U.S. Attorney in the U.S. Attorney's Office for the Eastern District of New York (EDNY), where she has been a prosecutor since 2015. She also serves at the Office's Reentry Coordinator, in which capacity she has worked with the Office's Reentry Committee to develop and launch various reentry initiatives including developing and proposing EDNY's Reentry Court program, which is launching this fall, outreach to a federal Residential Reentry Center (RRC) or halfway house and running reentry simulations for a variety of participants.

Gladian Rivera is the Victim-Witness Specialist (VWS) assigned to the International Narcotics and Money Laundering Section, where she supports and coordinates services for federal-level crime victims and assists federal law enforcement partners with prevention efforts to mitigate the proliferation of fentanyl. In addition to her work as a specialist, Gladian is an active member of the Office's Reentry Committee and has played a crucial role in developing the RAISE Reentry Court Program. She also coordinates federal-level reentry initiatives for the Eastern District of New York. Gladian's passion for reentry work stems from her belief that every person deserves a second chance. Her dedication and hard work have earned her the respect of her colleagues and the wider community, and she continues to be a driving force in the fight for fair and effective reentry policies.

Tholyn Twyman serves as the Reentry and Community Outreach Specialist for the United States Attorney's Office for the District of Maryland. Ms. Twyman is the coordinator and subject expert in matters regarding returning to society from incarceration and detention, barriers that justice-involved persons face, and youth violence reduction and community engagement. She also advises several organizations and government agencies on strategies for effective ways to help returning citizens and their families, organizes community-based reentry resource fairs, and maintains the only state-wide reentry resource guide, published on the Office's site. During her tenure as a community outreach specialist, Ms. Twyman has served as the Office's Coordinator as well as the Chair of the Maryland Statewide Alliance for Returning Citizens. Prior to joining the Office, Ms. Twyman was a Deputy Director in a District Government agency under the Deputy Mayor of Public Safety and Justice. She also spent several years as the first Youth and Reentry Program Administrator for the Baltimore (City) Police Department and has received several awards for her work with reentry, youth, violence reduction, and a Maryland Governor's Citation for her community-based work in violence prevention.

<u>Dr. Kimberlynn Reeves</u> is the official spokesperson for the U.S. Attorney's Office. Dr. Reeves provides counsel to the U.S. Attorney on law enforcement, community relations, and media affairs. Prior to joining the U.S. Attorney's Office, Dr. Reeves served as an advisor providing guidance for a newly implemented state court victim offender mediation program. Her leadership yielded restorative justice, providing victims and offenders a structured secured environment for face-to-face meetings. As a pioneer in her field, Dr. Reeves devises customized strategies and programs that advance the District's crime prevention goals. Dr. Reeves partners

across different layers of law enforcement, government entities, educational institutions, faith-based agencies, and non-governmental organizations garnering their participation and support required for successful implementation. Dr. Reeves' innovative approaches enhance enforcement initiatives, promote offender reentry, and foster communal healing. Her ability to effectively leverage and disseminate collective knowledge has been instrumental in crime suppression and enforcement efforts. As a passionate proponent of justice, Dr. Reeves frequently serves on panels, working groups and committees affecting policy and programs on civic engagement.

Mia Lamb is a Reentry Specialist with the U.S. Department of Justice United States Attorney's Office, EDPA. Ms. Lamb oversees the districts three federal problem-solving courts, STAR (Supervision to Aid Reentry/Reentry Court), STRIDES (Strategies That Result in Developing Emotional Stability/Mental Health Court), and RPC (Relapse Prevention Court/Drug Court). She provides resources and support for individuals transitioning home from federal prison. Additionally, she is part of the USAO Office of Public Affairs and External Engagement and assists in establishing partnerships in the community, developing, and coordinating new programs. Prior to joining USAO EDPA, Ms. Lamb served as a Reentry Case Manager for the Delaware Department of Corrections, where she conducted discharge planning at Level IV and Level V facilities across the state providing wraparound services to individuals as they transitioned from incarceration back into the community. Ms. Lamb holds her Master of Science Criminal Justice -Concentration Behavior Management from Saint Joseph's University, and her Bachelor of Science Criminal Justice from West Chester University.

Workshop Description: This workshop is designed to present a variety of simple do-it-yourself techniques that have been proven to help reduce anxiety, stress, and depression. Correctional and Law Enforcement personnel, including COs, counseling & service employees, and even management staff, can experience a full range of mental and emotional health concerns, including anxiety, stress, and PTSD, the same as everyone else. However, in addition to being subjected to similar risk factors, stressors, and life situations as other adults, correctional and LEO staff are often exposed to many more intensely stressful situations than the average individual. As a result, they may be more prone to find themselves in an anxious state than people working in other professions, and may even develop significant, persistent anxiety and stress-related conditions, including major depressive disorders, post-traumatic stress disorder, and others. Learning about and regularly practicing some of these simple evidence-based stress reduction methods have been scientifically proven to help alleviate these mental & emotional problems. In addition to some basic information on how daily anxiety and stress can lead to serious ongoing mental and physical health conditions, through a PowerPoint, printed handouts, and the opportunity to ask questions and discuss the presentation content, participants will learn about a number of simple, hands-on, evidence-based techniques proven to reduce and even eliminate anxiety, stress, and depression, whether jobrelated or not. Several simple exercises will be demonstrated during the workshop, along with a number of other methods that will be described in detail, allowing participants to try them out on their own whenever and wherever they may choose.

Her career started as an Assistant Prosecutor, before transitioning to the Office of the Attorney General – Division of Law, where she addressed law enforcement and corrections matters, including federal and state court litigation, excessive force, Megan's Law, conditions of confinement and assisted in the development of the protocol regarding the sexually violent predator and CSL/PSL laws. Before she was appointed Commissioner for the NJDOC, Kuhn served as the Department's Chief of Staff, and previously as the Deputy Chief of Staff, spearheading a number of initiatives. Prior to those roles, Kuhn led the Department's Equal Employment Division, which is charged with ensuring a discrimination and harassment-free work environment. Ensuring the Department realizes its mission of operating safe and humane correctional facilities is the Department's core focus, along with the holistic rehabilitation of people who are incarcerated through behavioral therapy, addiction treatment, vocational and educational training, and staff well-being through training and issuance of holistic health resources.

<u>Dr. Laurel R. Harry</u> was named Acting Secretary of the Pennsylvania Department of Corrections (DOC) by Governor Josh Shapiro in January 2023 and was unanimously confirmed by the Pennsylvania Senate on June 22, 2023. A 24-year veteran of the DOC, Dr. Harry began her career in 1999 as a Drug and Alcohol Treatment Specialist II at SCI Waynesburg. Dr. Shaffer first joined the staff of Patuxent Institution in 1997 as a provider of direct clinical services to incarcerated men and women, and her life's work has been dedicated to the remediation of Maryland's incarcerated population ever since. During her tenure, Dr. Shaffer has been one of the correctional facility's key leaders in such roles as Program Manager and Associate Director for Behavioral Sciences. Workshop Title: Motivational Interviewing in Action: Questions

Workshop Location: Stadium 1

Workshop Description: Motivational Interviewing is a style of communication that evokes a person's own reasons and strategies to make pro-social choices. It is often said that MI is easy to learn but hard to master. Many corrections professionals attend a two-day workshop, but leave not knowing how to incorporate what they learned into their daily work. This workshop focuses on just one key skill that we use every day: QUESTIONS. We will go beyond the basics and consider how our questions can help or hurt our engagement with justice-involved persons, and either heighten or dampen their motivation to make healthy decisions. Participants will have opportunities to practice this skill, and will be equipped to immediately improve the quality of questions in their interactions.

Bio: Ms. Karen Gautney is a member of the Motivational Interviewing Network of Trainers (MINT). She has over 30 years' experience in criminal justice, counseling, and non-profit management. That includes providing front-line risk reduction services to justice-involved persons in prison and under community supervision in Vermont-both individual CBT interventions and facilitation of manualized curricula. She has trained officers, staff and DOC-contracted agency personnel across the country in principles of effective intervention, core correctional practices, and other evidence-based models. Ms. Gautney has master's degrees in counseling and in criminal justice. She is currently a semi-retired consultant focused on helping corrections professionals integrate Motivational Interviewing into their ongoing work.



Workshop Title: Planning Your Professional Transition from Corrections

Workshop Location: Stadium 3

Workshop Description: Inform and discuss with attendees the importance of developing a plan when they leave the field. Given the comparatively low retirement age of correctional professionals, combined with the real possibility of a necessary/unforeseen early retirement (injury, etc.), it is imperative that agencies assist staff in being prepared for the next chapter of their life.

Dr. Lawrie was hired by the Connecticut DOC in October of 1993, spent three months being trained in the academy, nine more months on a working test period and then 19 years doing the job. He retired on 11/01/13 and the next day it was a completely new life with no assistance to help in the transition. He believes that agencies need to develop robust programs to work with staff, throughout their careers, to help them prepare for that transition. These issues will be discussed in detail.

One example that will be addressed is the need for more correctional professionals pursuing advanced/terminal degrees for academic, consulting and research-based goals. While Dr. Lawrie does not feel higher education is for everyone, and multiple types of careers will be discussed, this is an example of a professional need that would be relevant to the audience.



Workshop Title: Xylazine Awareness

Workshop Location: Stadium 3

Workshop Description: The New Jersey Department of Corrections (NJDOC) - Special Investigations Division has recently heightened its awareness of the potential dangers associated with Xylazine and its impact on the prison system. As a result, the division is actively investigating the use and effects of this substance within correctional facilities. Discovered in 1962 as an antihypertensive agent, Xylazine is often referred to as "Tranq" or "Trank." Xylazine comes in a liquid form that can be easily converted to powder. Xylazine is considered illicit for private ownership due to its classification as a non-DEA scheduled drug. In the United States, its acquisition requires a valid license in veterinary medicine, as it is primarily intended for use as a sedative in large animals. Although it is an affordable sedative option, its restricted nature ensures proper control and responsible use within the veterinary industry. Consequently, federal authorities have noted a significant increase in drug distribution originating from Puerto Rico, owing to the prevalence of equestrians who have convenient access to the substance.

In 2015, Paul was selected by the Correctional Staff Training Academy (CSTA) as an adjunct Academy Instructor. In 2016, Paul was selected as a Full —Time Instructor at the CSTA. In 2017, Paul was promoted with the Special Investigations Division (SID/Internal Affairs Unit) and graduated from The Division of Criminal Justice Academy. In 2021, Paul was selected to the Professional Standards Unit, which is a specialized unit in SID that handles a variety of investigations. Those investigations primarily focused on staff corruption and high-level internal investigations. In 2023, Paul was selected to the SID Training & Recruiting Unit (TRU), which is responsible for SID In — Service Training as well as the hiring process for new investigators. Paul attended Saint Peter's University and graduated with a Bachelor of Arts Degree. Paul furthered his education and attended Seton Hall University, graduating with a Master's Degree.

Principle Investigator Quiana Whitmore began her employment with the New Jersey Department of Corrections (NJDOC) as a Correction Officer at the Central Reception and Assignment Facility (CRAF) more than two decades ago. In 2009, she became an adjunct instructor at the Correctional Staff Training Academy (CSTA) and has taught various instructional units from the NJDOC - CSTA curriculum. She was promoted to Correction Sergeant in 2010 at CRAF, where she supervised a shift of Correction Officers and ensured safety and security of the facility. Quiana returned to the CSTA as an adjunct Sergeant/Instructor until she was selected as the full-time Custody Recruitment Unit (CRU) Sergeant. In 2014, she was promoted to Senior Investigator within the Special Investigations Division (SID/Internal Affairs Unit) and graduated from The Division of Criminal Justice Academy. In 2016, she was deputized by the U.S. Department of Justice Federal Bureau of Investigation and the United



States Marshals – Safe Street Task Force for her undercover role in a high-profile case. In 2017, Quiana worked as a Senior Investigator at CRAF. In 2020, Quiana was appointed as the SID Training Coordinator and was selected as an Investigator within the Professional Standards Unit. In 2021, she was elevated to Principal Investigator at Mid-State Correctional Facility, responsible for supervising Investigators and Senior Investigators. In 2022, Quiana played a major role in the creation of SID's Training & Recruiting Unit (TRU), and in 2023, she was selected as the supervisor of TRU. The unit is responsible for SID In – Service Training as well as the SID Hiring Process for new Investigators. Senior Investigator Kevin Bray is a fifteen-year veteran of the New Jersey Department of Corrections (NJDOC). In 2011, Kevin was selected to be a member of the Special Operations Group - Corrections Emergency Response Team (CERT). In 2015, Kevin was selected by the Correctional Staff Training Academy (CSTA) as an adjunct Academy Instructor. As an Academy Instructor at the CSTA, Kevin was responsible for teaching Correction Officer Recruits multiple aspects of training including Firearms, defensive tactics, physical training, baton, and multiple classes regarding academy curriculum. In 2017, Kevin was promoted to the Special Investigations Division (SID/Internal Affairs Unit) and graduated from the New Jersey Division of Criminal of Criminal Justice Academy. In 2022, Kevin was selected to the Technical Services Unit / Drug Interdiction Unit. Kevin successfully completed the New Jersey State Police 118th Crime Scene Investigations Course. Senior Investigator Dominick Puzio has over two decades of experience with the New Jersey Department of Corrections (NJDOC). Dominick started his career in 2001, at New Jersey State Prison, Trenton (NJSP) as a Correction Officer Recruit. During his time at NJSP, Dominick was a member of the Threat Supersession Team (TST), which was responsible for gang identification and confidential searches. In 2007, Dominick was selected by the Correctional Staff Training Academy (CSTA) as an adjunct Academy Instructor. In 2008, Dominick was selected as a Full –Time Instructor at the CSTA. In 2011 Dominick became a Mentor/Lead Instructor at the CSTA, training future academy instructors. In 2015, Dominick was promoted with the Special Investigations Division (SID/Internal Affairs Unit) and graduated from The Division of Criminal Justice Academy. Dominick held the position of Senior Investigator at South Woods State Prison (SWSP), New Jersey State Prison (NJSP) and Garden State Youth Correctional Facility (GSYCF). Dominick is also a peer leader and assists in in-service training molding the future state Investigators for the NJDOC.

Bio: <u>Jeff Nines</u>, Warden North Branch Correctional Institution- Serving in my 29th year of state service. Mr. Nines began his career as a Correctional Officer in Hagerstown, MD at MCI-H. Transferring into Case Management at WCI, located in Cumberland, MD, Sept. 1997. He served as WCI's Litigation and Inmate Grievance Coordinator until promoted to Case Management Supervisor in 2007. In 2015 Mr. Nines was appointed Assistant Warden at NBCI in charge of Program Services, Food Service and Medical Departments. In 2020 appointed to his current position as Warden, NBCI.

J. Philip Morgan began his career in 1977 as a Correctional Officer at the Maryland Correctional Institution-Hagerstown (MCI-H). He was promoted to Captain in 1990. He also served as a member of the institutional and regional tactical unit, including as MCI-H's Tactical Commander from 1990 to 1992. Due to his extensive experience in Emergency Preparedness, Tactical Operations, and Security Audits, Mr. Morgan was appointed Director of Emergency Preparedness and Tactical Operations at Division of Correction Headquarters in 2000. In 2002, Mr. Morgan briefly served as the Security Chief at North Branch Correctional Institution before returning to Division of Correction Headquarters as Assistant Director of Security Operations. He later became the Director of Security Operations. Mr. Morgan's career continued to advance, with appointments as Assistant Warden at MCI-H in 2007, Warden of Western Correctional Institution in 2009, and Warden of Maryland Correctional Training Center in 2011. In December 2019, he transitioned to the Jessup region, where he served as Warden at Maryland Correctional Institution-Jessup until December 2019. In December 2019, Mr. Morgan was appointed Assistant Commissioner of the Eastern Region of the Division of Correction, and in January 2021, he became the Deputy Commissioner of the DOC. On April 5, 2023, he was appointed as the Commissioner of Corrections (DOC), a position he currently holds.

Frank B. Bishop, Jr., began his career as a Correctional Officer at the Maryland Correctional Training Center (MCTC) in Hagerstown, Maryland in June of 1983. He transferred to the Western Correctional Institution (WCI) in February of 1996. He rose through the ranks becoming Sergeant in 1996 and instituted the Adjustment Process for WCI. He was promoted to Lieutenant in 2000 and appointed as Housing Unit Manager in 2002 and on to the rank of Captain (Asst. Shift Commander) in 2004. Mr. Bishop was appointed to Chief of Security at WCI in August 2006. In 2009, he was transferred to NBCI as Chief of Security to assist North Branch in its many obstacles and to help assist in stabilizing a violent and troublesome institution. In November 2011, Mr. Bishop was promoted to Warden and transferred back to WCI. In February 2014, Mr. Bishop was again appointed to NBCI as Warden to usher in a new era for the facility. December 8, 2014, he was appointed as Acting Assistant Commissioner of the North Region while the department underwent reorganizational changes and structure. April 1, 2015, Mr. Bishop returned to NBCI to continue his appointment as Warden. In December 2019, Mr. Bishop was appointed Assistant Commissioner of the Western Region of the Division of Correction.

Bio: <u>Michael Carrington</u> currently serves as the PA Department of Corrections Statewide Veterans Coordinator. He was appointed to this position in December of 2020. Michael began his employment with the Commonwealth of Pennsylvania as a Corrections Officer in 2007, following an honorable discharge from the United States Marine Corps as a Sergeant in 2006. Workshop Title: Enhancing Evidence-Based Practice in Sex Offender Treatment

Workshop Location: Stadium 3

Workshop Description: Evidence-Based Practice (EBP) is the standard of care in therapeutic mental and behavioral health treatment. However, there are significant lapses in the treatment protocols mandated within the correctional system for people who have been convicted of sexually based offenses, primarily due to a lack of individualization and appropriate, effective methodologies. This presentation is based on an extensive study that details those lapses within the correctional mental and behavioral treatment setting and describes how more effective EBP therapeutic approaches could be incorporated to improve the sought-after outcomes in sex offender management and treatment. This presentation should be of interest to those who manage sex offender treatment programs as well as those who conduct counseling and therapeutic programs for this population.

Bio: <u>Dr. Gene I Katz</u> is a Subject Matter Expert on sexually based offenses, as well as on evidence-based therapeutic interventions for sex offenders, and has been invited to speak as such on numerous occasions before Colorado's State Legislature, as well as the Dept of Corrections, and Sex Offender Mgmt Board. A psychotherapist and founding member of the Colorado Mental Health Professionals Association, a senior member of the Academy of Criminal Justice Sciences, and an Associate Professor in the College of Criminal Justice and Health Services at Colorado Technical University, he also developed the course Sex Crimes: Behavior & Consequences, one of the first such classes in the US.

He has also earned citations of recognition from both the US Congress and the NY State Legislature for his achievements in Community Mental Health.

This important work will ultimately lead to a reduction in recidivism. Participants will learn The Tisdale's Ten Techniques, Coping Skills, Life Skills, Professional Development and Life Transitions.

A Leader in Reentry, Mental Health and Substance Use Disorder Treatment
